- The selection will be done through a walk-in interview at the office of ICCS.
- Eligible candidates will be informed by email/telephone call (*only via email or telephone call; hence ensure that a working email and telephone number is provided*) regarding the selection.
- All the appointments will be **purely temporary and on contract basis**. For Post Codes 01 & 02, the appointment is for a period of one year (subject to satisfactory completion of 3 months after the appointment) or till the completion of the project (whichever is earlier). It may be extended for another year or until project completion (subject to satisfactory performance as evaluated by a competent authority).  
\* For Post Code 03, the appointment is initially for six months.
